**Minutes for February 3rd, 2020**

- Meeting called to order by President Stewart Robinson at 7:03 pm.
- Board members present; Stewart Robinson, Mario Muniz, Richard Lawrence, Eddie James, Kevin McDaniel, Don Turner, Vince Michaels, Steve Staudenmeir
- Guest members present: None
- The status of the Lewis lawsuit against the club was discussed. No significant developments at this time. The attorney retained by the club is in communication with the attorney for the opposing party.
- The club continues to investigate various alternatives for the new club main field. The Board believes that it would be best if we have more than one option available. The alternate site proposed by the City of Hemet continues to be a possibility and there have been no changes to that. Also, the club's Davis field is also a possibility. To date, no other viable potential sites have been identified but the Board is actively investigating.
- The club is investigating club liability insurance options. The AMA does provide some coverage but it is somewhat limited. One challenge we are finding is that to obtain umbrella insurance, the company's that offer it have no experience with RC clubs like ours and thus don't offer it. The Board will continue to explore potential options.
- IMAC is seeking a club to host their regional championship in November and has asked whether our club would serve as host. The Board was in favor of this and will communicate with the IMAC organization regarding next steps.
- The club bylaws are somewhat out of date and the Board agreed that these need to be reviewed and updated this year.

**HEMET MODEL MASTERS GENERAL MEETING**  
**Minutes for January 18, 2020**

Meeting called to order by Stewart Robinson at 9:06 am

- Pledge of allegiance
- Meeting minutes Motion to accept by Vince Michael and seconded by Jeff Malecki, all approved.
- Treasurers report: was reported by Treasurer Stewart Robinson. Motion to accept by Don Radford, seconded by Don Turner, all approved.
- No guest or new members were in attendance.

Old Business:

- The club is still exploring options for the club's new flying location including where and when the move might take place. The site the City of Hemet has proposed is larger than our current main field but not as open and flat. We will also consider whether our Davis field could be transitioned to become our main flying site. Although we cannot put down a paved runway, there are other options. Richard Lawrence suggested that Davis might be a good candidate for poly pavement.
- The club has retained an attorney to represent the club in the lawsuit against the HMM as this is what is required by law. The response date is currently on hold because all defendants named in the suit have not been served. The response period (30 days) will start once all defendants have been served.
- Stewart Robinson reiterated that or club's goal is to serve all types of RC flying and that we want to avoid factions committed to one type of flying or another.

New Business:

- The upcoming IMAC event is a go and is scheduled for April 4th and 5th. The club is communicating with IMAC to determine what support of support will be required from the club.
- The club is exploring liability insurance options to protect the club and the members. Currently the AMA insurance does indemnify the Officers carrying out club duties but other options are being explored.

Safety:

- Safety Officer Vince Michael said that club members have been doing well from a safety perspective and he had no concerns to report.
- Vince did remind members to please avoid flying over or near the shade structures on the East side of the pit area.

Show and Tell: None for January.

Raffle: The club raffle will resume in February.

Sportsman, Intermediate, Advanced, Masters, FAI (P-18, F-18), and FAI Silver if there is enough interest will be flown. Awards to 3rd place in each class. This is an AMA sanctioned event so proof of AMA membership must be provided when registering. Sportsman Class will be allowed to fly any AMA legal airplane. \$40 for all classes except Sportsman which is \$30. Lunch will be available at the field for a nominal fee. Water is complementary. Camping is allowed at the field – no hook-ups.

Field is open at 8:am, with pilots meeting at 8:45 – wheels up at 9:00. Sun is an issue here in the afternoon, so we must get things started early. 2 flight lines will be used with contestant judging. If we have 10 or more participants in Masters and/or Advanced, we may split the class for judging. For the last 2 rounds on Sunday, we will offer the F-18 schedule for FAI.

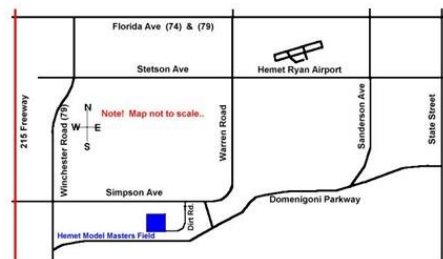

### **Metropolitan Water District**

**Aqueduct Information for Retrieving crashed aircraft. Mike Thompson is the service representative that services the aqueduct near our main field. If your airplane is behind the second fence and not in the water runoff it is serviced by Mike Thompson. His direct line is 626-844-5610. Note: Before calling be nice and explain that you are with the Hemet Model Masters and that you have crashed you're rc plane beyond the second fence and would like to retrieve it without breaking any laws. If your plane is between the first and second fence it is serviced by another agency (Securitas Security), Mike Thompson can not help you. Hopefully this will help our members to retrieve their aircraft.**

### **Permanent TFRs issued for major sporting events and Disney properties**

**On October 27, 2018 the FAA issued three Permanent Temporary Flight Restrictions (TFRs) creating restrictions for the airspace surrounding major sporting events and the Disney properties in Anaheim CA and Orlando FL. The new flight restrictions permanently prohibit the operation of unmanned and radio-controlled model aircraft within roughly 3.5 miles of both the Disneyland and Walt Disney World theme parks. The restrictions are also in place for a period of one hour before and one hour after major sporting events.**
